The City of Lumberton Tax Collector shall refuse to issue a license or shall revoke a license for either of the following reasons: (A) The applicant misrepresents a fact relevant to the amount of tax due or his or her qualifications for a license or (B) The applicant refuses to provide information necessary to compute the amount of tax due.

(Section 12-47 Lumberton City Code)

A license or his assignee shall report a change in the information contained in this application to the City of Lumberton Tax Collector within (10) days after the change occurs. If the information shown on the license itself is affected thereby, the licensee or his assignee shall surrender the license to the Tax Collector when reporting the change.

(Section 12-54 Lumberton City Code)

Each person who conducts business taxed hereunder shall keep all records and books necessary to compute his/her tax liability and shall permit the City of Lumberton to inspect the business conducted to examine the books and records to determine the nature and amount of business transacted. (Section 12-61.3 and Section 12-61.4 Lumberton City Code)
